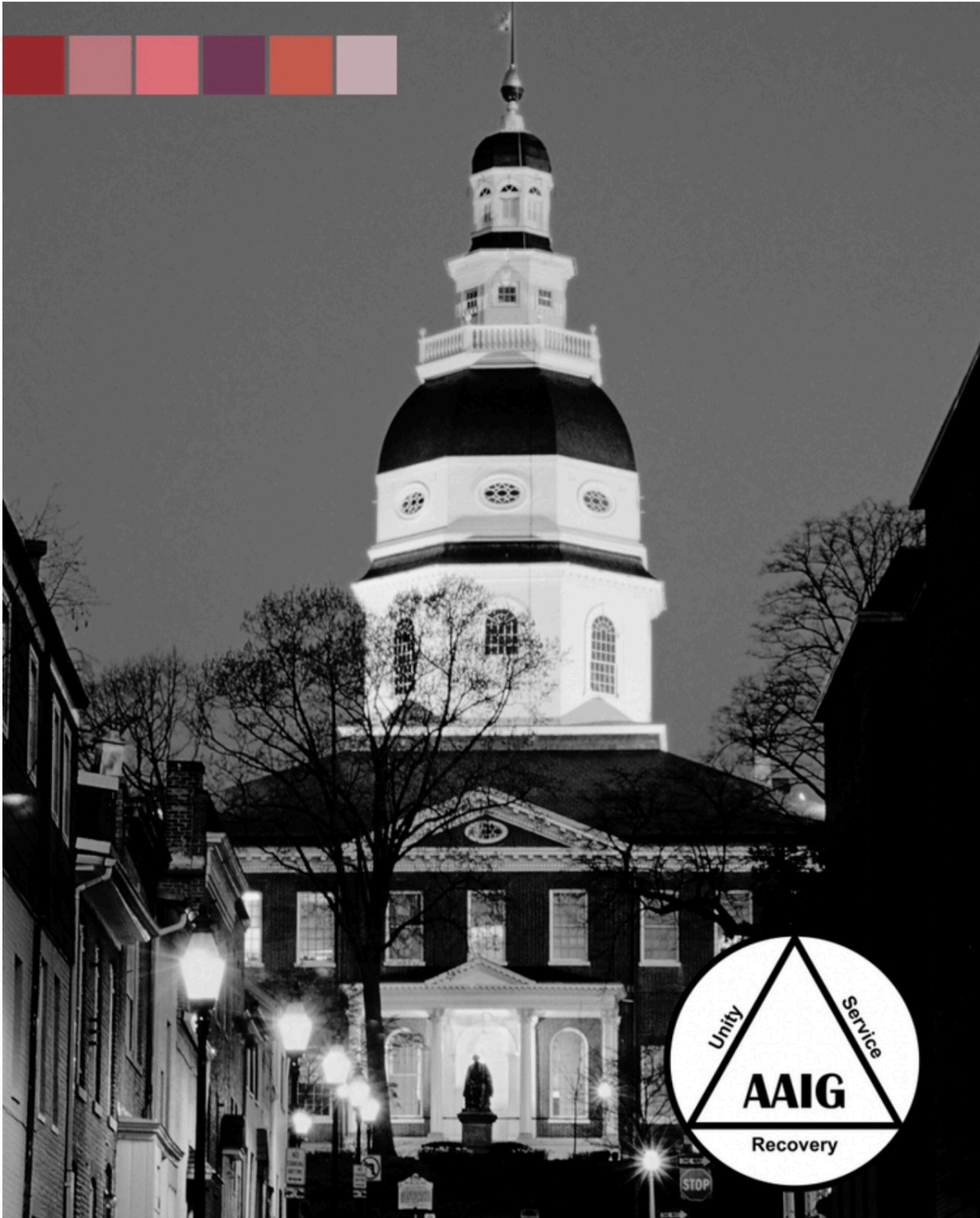

### HOW DOES OUR INTERGROUP WORK?

#### **Annapolis Area Intergroup**

The Annapolis Area Intergroup, Inc. is a non-profit corporation whose Council is composed of one elected representative from each participating Alcoholics Anonymous Home Group, Committee Chairs and elected officers (Chair, Vice Chair, Treasurer and Secretary). The Council provides many functions not found in the General Service Structure. It is the purpose of the Intergroup Council to uphold AA's Twelve Traditions and to organize service to best "carry the message" to the still suffering alcoholic.

The Intergroup Representative (IGR) is the link between the Group and the Council as well as the Intergroup office. Through the IGR the Council learns of the needs and issues of the Group and learns the needs and issues of the Council. The IGR takes the issues discussed at the Council back to their home group and seeks the group's conscience. The IGR then votes on those issues at the Intergroup Council meeting.

The Council meeting is held on the 3rd Tuesday of every month. This is a meeting for reporting on Group financials and committee reports. The standing committees are: Activities, Archives, Bulletin, Corrections, Finance, Literature, Outreach, Public Information, Red House Desk, Technology and Treatment.

IGRs are responsible for the overall operations of the Intergroup, but in no way affects the individual AA groups. Membership is voluntary and involves no financial obligation. However, the operation and services provided by the Intergroup are dependent on contributions.

## OUR BYLAWS

The Annapolis Area Intergroup conducts 12th step work for the Fellowship with the assistance of bylaws. The purpose of our bylaws is to guide actions and decisions and acts as the organization's operating rules. Bylaws can be helpful in resolving common issues which may arise throughout the year. They protect the Fellowship from potential problems consistent with our Traditions. See our [Handbook](#) for a full review of each of our bylaws.

A most recent example of our bylaws being utilized was our election in December 2025. Elections are conducted pursuant to Article 12. This article lays out how our elections are conducted, to include eligibility to vote. While our 2026 candidates had no opposition, Article 12 provides guidance in the event of multiple candidates for each officer.

In February the Council will vote to approve the 2026 budget. Article 6, section 13 of our bylaws is specific on timing guidance. It states *"Treasurer and/or Finance Committee will present an annual operating budget for adoption at the February Intergroup Council meeting"*. The Council, made up of Intergroup Representatives vote after the presentation of the budget.

Dear A.A. Friends:

Warm greetings – we hope this letter finds you well.

We are writing to inform you of an upcoming literature price increase affecting our English, Spanish, and French books, booklets, pamphlets, and other literature items. At the December meeting of the A.A. World Services Board, the board approved a price increase of \$3 per item for books and a 15 percent increase for all other literature items, with standard rounding applied.

The new prices will go into effect on February 1, 2026.

For historical perspective, the last price increase occurred in April 2023, and the previous increase was in 2014. As with the 2023 increase, this decision is the result of prudent fiscal planning and the goal of long-range stability. Like organizations everywhere, Alcoholics Anonymous is impacted by current economic changes and challenges. One of the most significant challenges we continue to face, as we did in 2023, is the increasing costs associated with the sale of literature.

It is important to note that before the COVID-19 pandemic, the combined costs of production, materials, warehousing, and shipping—collectively referred to as the cost of goods sold—generally ranged between 31% and 34% of sales. Over the past several years, those costs have fluctuated between 42% and 56% of sales, resulting in an annual revenue loss exceeding \$1.8 million. We do not expect these costs to return to pre-pandemic levels. This impact is especially significant given that the General Service Office is supported through both voluntary contributions and revenue generated from literature sales.

We continue to diligently and carefully monitor and reduce expenses where possible, always mindful of the profound significance of each “nickel in the basket” sent to the General Service Board.

Updated pricing will be reflected in the online store when the increase goes into effect.

For this increase, the following guidelines will apply:

- **Books** are defined as any item whose item number begins with **B, SB, or FB**.
  - These items will receive a **\$3 per-item increase**, excluding B-0 (*Alcoholics Anonymous* Facsimile First Printing of the First Edition—recently reduced to a discounted \$2 USD List Price) and B-28 (*A.A. for the Older Alcoholic*).
- **B-0** will remain unchanged and is the only exception to the book price increase.
- **B-28** will receive a **15% price increase**.
- **All other literature items** will receive a **15% price increase**.
- **Literature sets** will reflect a **\$3 increase per book**.

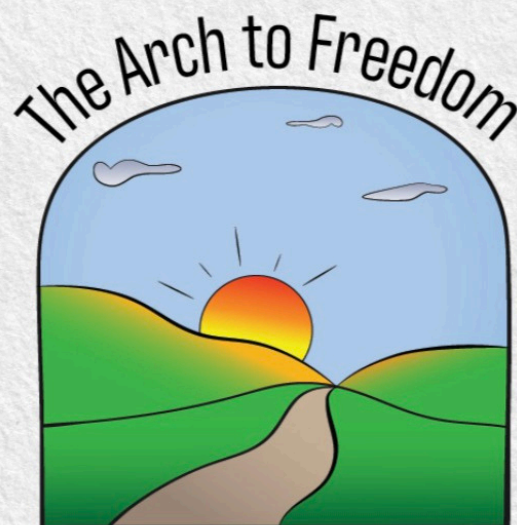
